# TERMS AND CONDITIONS OF THE TENDERS INVITED FOR THE SUPPLY OF ITEMS INDICATED IN THE SCHEDULE FOR THE YEAR 2016-18

- The details of item to be supplied to the Milk Products Factory TSDDCF LTD, Lalapet, Hyd-17 for which the Tenderer have been called for by the Managing Director, TSDDCF Limited, Lalapet, Hyd-17 is indicated in the Schedule appended here with.
- 2. The Tender forms and schedules are not transferable or assignable.
- 3. The individuals signing the Tenders and connected papers should specify the capacity in which they have signed the tender documents
- 4. The rates should be quoted in the tender schedule legibly in ink and the Tender should be sent in a sealed cover addressed to the General Manager, Milk products factory, TSDDCF, Ltd Lalapet, Hyderabad-17, preferably by registered post super scribed as tender for the supply of MaterialsDue on19.12.2016by 1.00pm.
- 5. The last date for the receipt of sealed tenders, in the office of the Deputy Material Manager, Milk Products Factory Hyderabad, either in person or by a post is up to 1.00pm on 19.12.2016. The Tenders received after the due date and time shall be summarily rejected.

- 6. The Tenders will be opened on 19.12.2016 at 3.00 am by the General Manager or his nominee in the office of the General Manager, Milk Products Factory, Lalapet, Hyderabad and in the presence of Tenderers or their authorised Representatives. If the said date is declared as a holiday the tenders shall be received and opened immediately on the next working day at the same time and place.
- 7. Each tender should be accompanied by EMD in the shape of bank draft. The amount to be given as EMD was clearly given in the price schedule against each item, the Earnest Money Deposit in the case of Demand Draft it would be drawn on any Nationalized schedule Bank in twin cities at Hyderabad. The Demand Draft should be in favour of Managing Director. TELANAGANA STATE DAIRY DEVELOPMENT COOPERATIVE FEDERATION LIMITED, LALAPET, HYDERABAD -17. No cheques and postal orders or any other mode of Remittance will be accepted.
- I. There will be no exemption from the payment of Earnest Money Deposit. The Earnest Money Deposit will be returned to the Unsuccessful Tenderers with in due course.
- II. Tenders received and found defective in any other respect are liable to be rejected Summarily.
- III. Tenders containing vague and ambiguous expression like "subject to prior sale" or "subject to stock being available" or "subject to immediate acceptance" etc or putting any counter clause other than what has been a specified will not entertained.
- 8. The rates tendered should be in items of rupees and paisa for the unit of quantity noted in the tender schedule and must be expressed both figures, and words. More than one rate should not be quoted for the same Item/quality. Over writings, or interpretation should not be there. The revised figures, if any should clearly write and attested by the Tenderer.

The rate should be exclusive of VAT and CED and other Taxes ruling as on the Date should be specified separately and the final price shall also be quoted in the column provided. If no specific mention is made than the rate quoted will be treated as inclusive of VAT, CED/ All other Taxes and levies as applicable. The delivery of goods should be affected preferably by road. The rates should be quoted for delivery at the places noted in the schedule annexed here to inclusive of Transit risk. Minimum size of order and load time required should be indicated by the Tenderer.

- 9. The rates offered should be kept open for acceptance by the federation / Milk Products Factory, Hyderabad for 90 days from the date of opening of tenders. Failure to accept the contract order within this validity period shall lead to the for feature of EMD besides further action to recover the damages/losses sustained by the federation on the above account during the period of contract.
- 10. The successful tenderer shall be required before the award of contract to furnish the Security Deposit equivalent to 5 % of the anticipated total value of the contract. The EMD will be taken in to account for purpose of adjustment. No claim shall lie against the Milk Products Factory, for the interest on the EMD and SD. The successful tenderer shall be required to sign an agreement in the form of prescribed by the Federation. The Security Deposit as stipulated shall have to be remitted by the approved tenderer within a week from the date of receipt of acceptance letter by way of crossed Bank Draft drawn in favour of Managing Director TS Dairy Development Cooperative Federation Limited, Hyderabad-500017 on any scheduled Bank preferably on Canara Bank, Lalapet, Hyderabad-017 or Bank Guarantee as the case may be failure to comply with this condition shall make the tender liable for cancellation and forfeiture of EMD. The tenderer shall be liable to make out good to the Milk Products Factory the consequential losses if any on damaged.

- 11. The quantities furnished in the schedule is only approximate and the actual requirements/ demand may vary from time to time and the supplies shall have to be effected with 20 % variation on either side at the option of the General Manager, Milk Products Factory, Hyderabad over the quantity ordered for.
- 12. In case of delay or non-supply by the supplier in the performance of its timely delivery obligations, shall render the supplier liable to any or all of the following actions: (a) imposition of penalty at the rate of 2% of the value of the material to be supplied for the day wise delay termination of contract for default and forfeiture of security Deposit.
- 13. The period of contract for the supply of items indicated in the schedule shall be up to one year from the date of rate approval.
- 14. The Security Deposit of the approved tenderer will be released based on the satisfactory performance of the supplies during the period of Contract.
- 15. The General Manager reserves the right to reject any or all the tenders without assigning any reason therefore and the right to alter or modify or delete any of the tender conditions here in contained without notice. The General Manager is not bound to accept the lowest tender. His decision in regard to acceptance of tender or any dispute shall binding and final conclusive in all aspects.
- 16. The indenting tenderer shall sign the declaration from annexed here to invariably witnessed by two responsible persons. Each page of the tender schedule has to be signed at the bottom in the space provided for and the tender schedule have to be submitted duly filled in and signed even if the firm wishes to send a separate covering letter.
- 17. Two samples should be sent along with tender, for the items quoted and they are not returnable one.
- Tenderer should furnish photo copies of TSVAT Registration Certificate, the latest Sales Tax Clearance Certificate, and Income Tax Clearance Certificate.

- 19. Each Tender should clearly stipulate in separate letter head the following details.

  - d) Source of Raw Material.
  - e) List of Customers to whom the items quoted is supplied.
  - f) Minimum and Maximum quantities that can be supplied in each month in case of the offer is accepted.
